2018 Scholarship Application

QUALIFICATIONS

Applicant must be a full-time or regular part-time employee, or an immediate relative of someone who is a fulltime or regular part-time employee, of a company that is a member of the Oregon Telecommunications Association. The employee must physically work within the state of Oregon. Immediate relative may include spouse, son/daughter, sister/brother, parent or grandson/granddaughter. An applicant is eligible to receive an OTA scholarship a maximum of two times.

The applicant must also:

- Be currently enrolled or applying for admission to an undergraduate or graduate program in an accredited community college, four-year college or university, or vocational technical school.
- Use the scholarship in the 2018-2019 academic year.
- Be recommended by a sponsor who is a full-time or regular part-time employee of a company that is a member of the Oregon Telecommunications Association, and who physically works within the state of Oregon.
- Provide two letters of recommendation from individuals other than family members. <u>These letters must</u> <u>be dated in the current school year and must include the signature of the person writing the letter</u>.
- Provide legible copies of all high school and college or technical school transcripts.
- Student must maintain a 2.5 or greater institutional GPA on a 4.0 scale. <u>Recipients of the Diana</u> <u>Coleman Memorial Scholarship Award are exempt from this requirement</u>.
- Submit all information requested on the application form.
- Be certain to sign and date your completed application (Section I).
- Be certain to secure signed verification that the sponsor meets the employment requirements (Section II).

All required application-related materials, including dated and signed letters of reference, must be received by the application deadline for the application to be considered. <u>Incomplete or late applications will not be considered for a scholarship award</u>.

JUDGING WILL BE BASED ON THE FOLLOWING CRITERIA:

30 points	Academics [Students will be evaluated on GPA]
20 points	Education and Career Goals
20 points	Contribution to Community
15 points	School Activities
15 points	Personal Statement

APPLICATION PROCESS

- **1.** Complete Sections I through VII; attach additional sheets as required.
- 2. Be certain to sign your completed application (Section I).
- **3.** Have your employee sponsor complete and sign (top part of Section II). Have the employee sponsor's employment status verified by the company (bottom of Section II).
- 4. Completed applications and all supporting documentation must be received in the OTA office not later than <u>5:00 p.m. on Friday – March 30, 2018</u>. <u>A postmark of March 30, 2018 is acceptable if the</u> <u>envelope arrives after the deadline</u>. Applications can either be hand-delivered, mailed, emailed or faxed.

Incomplete or late applications will not be considered for a scholarship award.

<u>Please note</u>: We also ask that each applicant provide a current photo of him or herself, preferably digital. If applicant is selected to receive a scholarship, their photo will be included in an informational brochure promoting the Scholarship Foundation to be handed out at this year's annual conference.
