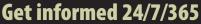
Consumer Services and Marketing Seminar

Commissioner Brad Avakian of the **Bureau of Labor and Industries** joined us to discuss workforce training programs that BOLI is developing. He also discussed current wage and hour law issues.

The 2014 Ray Hawkins Safety Employee of the Year Award was presented to Allen Baxter of SCTC. Allen has almost 20 years in the Outside Plant at Stayton Cooperative Telephone Company with no reportable accidents or injuries. Allen is always thinking ahead when planning jobs. OTA members, representatives and attendees should terminate any discussion, seek legal counsel's advice, or, if necessary, leave any meeting or discussion where improper subjects are being discussed and explain the reasons for departure to those still in attendance.

Jim Rennard from **GVNW Consulting, Inc.** joined us to discuss the latest developments regarding UM 1481 which proposes to extend the current Memorandum of Understanding through 2021.

Shane Ideus of **Unitel Insurance** spoke to the group on what to expect during a cyber incursion and how to trim exposure to loss.

Susan Doherty of **NECA** provided an update on a variety of current issues and tariff filings

"Consolidating Services" was the topic of a panel discussion facilitated by **Jennifer Niegel** of **Duncan, Tiger & Niegel** with panelists, **Jim Rennard** of **GVNW** and **Paul Hauer** of **Consolidated Business Services**. The panel discussed how companies are looking to consolidate management and other services, how that is currently working and what issues have arisen to date.

Brant Wolf, OTA and **Jeff Smith, GVNW Consulting, Inc.** teamed up to provide an overview of the legislative and regulatory issues affecting the telecommunications industry at both the state and federal levels.

Legislative Update... by Brant Wolf, CAE, Executive Vice President

This newsletter is for the last quarter of 2014. However, it is past that time and we are in the beginning of what could be an interesting legislative session.

By now Governor Kitzhaber has resigned his position and Kate Brown is now our Governor. This turn of events should not impact any of the issues that we might be involved with this session. By the time any of our issues make it as far as the Governor's office for action, we have taken all the action that we would probably be inclined to take. Once things have settled down, maybe after the session has included, OTA might reach out to the Governor and see if she might come and visit with us about those issues we care about.

We have started tracking quite a few bills and some of them have already had action taken. For example, legislation to renew the Oregon Broadband Advisory Council was considered and has already been voted out of the Senate. A few others have had hearings and OTA has offered testimony but nothing with any far reaching effect has moved out of any Committee.

Eventually there will be legislation considered that if passed would change the way cities can implement local franchise fees. In past sessions Comcast and the League of Oregon Cities (LOC) have sought to simply eliminate the law related to franchise fees. Over the course of a couple of years OTA and Comcast have agreed to language that would allow cities to charge a franchise fee on a broader range of services (not access to broadband) and have a lower cap of 5% on the fee. The bill would also allow us to pass along the entire fee on customer's bills. It is way too early to tell if this franchise legislation will pass or not. Regardless, this issue will be discussed. In fact, the cities have once again introduced legislation to completely eliminate franchise fee law. If this passes, a city could charge a fee on any service in any amount they choose. We will have to be vigilant about that particular legislation.

We are also in a pretty critical stage of the Oregon USF proceeding at the OPUC. While we thought we had this wrapped up for a while, that might not be the case. This is where we stand now: all parties had agreed or at least did not oppose an agreement that would have lowered the fund disbursements and placed a cap on the surcharge amount, among other things. This stipulation was sent to the Commissioners in September and in January it was rejected by them. All parties were ordered to go back to the beginning and try again. Without going into detail, this was a demoralizing, depressing outcome. Now there will be a workshop on April 16th with all three Commissioners in attendance that will hopefully educate the Commissioners about the Oregon USF, how it is used and how it came about in the first place. There are a few other issues OTA is engaged in at the OPUC but the Oregon USF proceeding is by far the most important. If you have time on the afternoon of April 16th you might consider attending the USF workshop. The Commissioners might actually call upon some folks to answer questions they might have. Even if they don't it will be important to demonstrate that we all care about the outcome of this docket.

Finally, I want to thank each and every one of you that contributed to the OTA Political Action Committee (PAC). Every year I ask and every year many of you respond to my request to fund the PAC. Our PAC gives us the opportunity to support people who support us and get to know newly elected legislators. We also have the opportunity to attend events that support legislators and those in leadership positions in the House and Senate. While our PAC will never be as large as some others it doesn't really have to be. We have a great story to tell and you all do good work in your communities. The PAC just lets us tell that story to a few people who might need to hear it.
