2015 Safety Seminar Recap

The OTA 2015 Safety Seminar was a one day event that took place on November 18th at the Comfort Suites Airport in Salem.

Kicking off the seminar was **David Briggs**, **Partner at Saalfeld Griggs**, **P.C.** who presented "**Drugs in the Workplace: A Review of Safety Concerns Port-Measure 91."** David reviewed what the legalization of marijuana for recreational purposes means for your workplace, and what you can and should be doing to ensure a drug-free workplace. David covered what Measure 91 does and does not do with respect to employment laws, and provided practical advice for handling issues that arise when crafting a lawful drug use and testing policy. He also addressed the struggles companies face in light of the use and abuse of prescription medication, including those employees in safety-sensitive positions.

Safety Recap, continued...

Mike Hetzel, Director-Risk Management Services for **Unitel Insurance** talked about **"Work and Home Safety and Security."** Mike covered how to enhance your safety at work as well as take what you have learned and apply it to your personal life at home or play.

Laurie Holien, Deputy Director at the Oregon Office of emergency Management (OEM) offered a presentation on "The Cascadia Threat and Emergency Coordination with the Telecommunications Sector." Laurie described how the State of Oregon is coordinating with the private sector owners and operators to streamline response efforts and describe how service providers can develop business continuity plans.

Daniel Multop, owner of **Multiple Computer Solutions** joined the group to discuss "**Security Threats and Best Practices**," covering what the most common cyber threats are, how to avoid them, and how to deal with them if they happen to you. He also discussed

different types of scams such as FBI-related scams, identity theft, computer crimes, untrustworthy websites, and the latest scams in the news.

Michael Van Wormer, Loss Prevention Consultant with **Great American Insurance** finished off the day's sessions with **"Outside Plant Safety and Ergonomics."** Michael talked about material handling issues (proper ergonomics), slips, trips and falls, driver controls, outside elements (heat and cold), ladder safety, proper tool selection, controls for entering a customer's home, fall protection and safety controls for trenching, boring and excavation.

OTA members, representatives and attendees should terminate any discussion, seek legal counsel's advice, or, if necessary, leave any meeting or discussion where improper subjects are being discussed and explain the reasons for departure to those still in attendance.
