**The primary purpose of this position is:** The OSP Planner is responsible for planning and supporting engineering projects for the company's plant infrastructure. #### **JOB DUTIES AND RESPONSIBILITIES:**

- Responsible for long-range planning, forecasting OSP facilities growth, maintenance and gives clear direction to Engineering staff.
- Responsible for determining the requirements for placement of, fiber and copper facilities in the feeder and distribution plant, including route placement, duct structure, cable placement and sizing, allocating fiber/cable counts, placement, and type of enclosures above ground and underground, drop placement, and electronics placement.
- Plans engineering projects to add new remotes, augment existing remotes, or decommission remotes as required, including bonding and grounding in compliance with industry and NESC standards.
- Forecasts work order costs including cost of materials, sub-contract, and labor costs. Tracks project costs against forecasted costs.
- Opens and closes work orders, obtains required permits, Rights of Way, and easements.
- Represents the company at preconstruction meetings and coordinates with public works personnel, developers, commercial customers, building owners, and utilities on joint trench projects.
- Assists and prepares detailed regulatory reporting i.e. 477,481, HUBB and future as they are developed by governing bodies.
- Coordinate contractor work, coordinate and/or obtains permits, access, or ROW agreements where applicable, distributes design prints and other necessary working documents. Negotiates and approves design or construction changes. Assigns ONT's and fiber counts, and issues splicing prints.
- Partner with a variety of telecommunication companies to deliver and implements procedures with consistent applications that are shared throughout the partner companies.
- Performs other job duties and responsibilities as required to fulfill job functions or as assigned.

#### **JOB REQUIREMENTS:**

- The ideal candidate will have 10+ previous experience in construction planning, engineering, or network operations in the telecommunications industry.
- High school diploma or equivalent. PMP or RTPM certification is a plus!
- Must have knowledge of industry codes, standards, and best practices.
- Knowledge of telecommunications construction and engineering practices and principals.
- Proficient in Excel and MS office, and understanding of Auto-Cad, NISC, ESRI, and smartsheet.
