In Memorium...

Ken Sandner passed away in December of 2020. He served as General Manager of Stayton Cooperative Telephone Company beginning in 1975 retiring after 16 years of service in 1991. He once owned Helix Telephone Company prior to selling it to the Smith family.

Ken Sandner was a quiet, soft spoken man who thought about what he was going to say before he said it.

Ken served as President of the Oregon Telecommunications Association from 1983 – 1985. He was awarded the OTA Outstanding Service Award in 1986 and became an OTA Honorary Member in 1997.

OTA members, representatives and attendees should terminate any discussion, seek legal counsel's advice, or, if necessary, leave any meeting or discussion where improper subjects are being discussed and explain the reasons for departure to those still in attendance.
