The primary purpose of this position is: The Facilities Locator Lead oversees staff members' daily tasks related to plant maintenance, facility identification and location, and facility issues for multiple CBS partner companies.

JOB DUTIES AND RESPONSIBILITIES:

1. Responsible for coordination and scheduling of the daily workloads of Locate Technicians, and Partner Contractor staff. Oversees Partnered Contractor for Underground Locate Services. Works with partnered contractor to resolve locate issues. Response to Underground Locate Services dig ups and fills out the proper paperwork for reporting of dig up to include billing of time and materials.
2. Understands underground construction procedures. Constructing prescribed conduit network in joint utility trenches, cable pulling, and plant rearrangement.
3. Provides support to Network Technicians and Splicing team to reach service target goals and provide guidance and encouragement toward skill enhancement and teamwork. Maintains team cohesion and sets the example through own performance.
4. Submits time reports, Equipment change outs, Time and Material invoicing, and all other forms timely. Keeps detail written records of work activities and assists in administration of field scheduling tool.
5. Participates in company and industry training required to maintain up-to-date knowledge of current technologies. Assists in leading the continuous IP knowledge and professional development of Network Technicians for current and future technologies.
6. Assists and performs troubleshooting and repair of outside plant facilities including copper and fiber optic cables, enclosures, terminations, and protection devices in both aerial and underground plant if required during inspection of facilities.
7. Acts in the capacity of the Field Operations Manager when not available and assigned.
8. Partner with a variety of telecommunication companies to deliver and implement procedures with consistent applications that are shared throughout the partner companies.
9. Performs other job duties and responsibilities as required to fulfill job functions or as assigned.

JOB REQUIREMENTS:

- At least two-years prior telecommunications experience; At least 1 year prior supervisory experience preferred.
- High School Diploma or equivalent relevant field experience is required.
- Must possess a strong knowledge and understanding of outside plant networks and fiber network architectures.
- Must possess knowledge of basic electrical theory, design, and telephony color codes.
- Ability to reach, bend, work from ladders at various heights, lift 75 pounds, and work in confined spaces or under other adverse conditions.
- Able to distinguish between colors used to identify wiring and mark underground utilities.
- Must possess a valid driver's license with a good driving record and have the ability to be insured under the company policy.
- Work occasional overtime if needed.
- Rotation between multiple sights multiples times a week is required.
